#### **RESOLUTION NO 25-05**

# RESOLUTION OF THE BOARD OF TRUSTEES OF THE \_\_SHASTA FIRE PROTECTION DISTRICT\_\_ ESTABLISHING THE APPROPRIATIONS LIMIT FOR FISCAL YEAR 2025-26

WHEREAS, the Article XIII B of the California Constitution requires certain special districts to establish an annual appropriations limit, and

WHEREAS, the limit is based on appropriations only from proceeds of taxes, and

WHEREAS, Government Code §7900-7914 and §2227-2228 provides the process in which to calculate the appropriations limit, and

WHEREAS, the Shasta County Auditor-Controller has complied with the provisions of Article XII B in determining the appropriations limit for fiscal year 2025-26; and

**NOW, THEREFORE, BE IT RESOLVED** that the Board establishes the Shasta Fire Protection District appropriations limit at \$ 291,303 for Fiscal Year 2025-26 and that the annual adjustment factors used to calculate the appropriations limit shall be:

- a) The percentage change (10.10%) in local assessment rolls from preceding year due to the addition of local non-residential new construction.
- b) The percentage change (-0.03%) in population within Shasta County, combined with the change in population within all counties having borders that are contiguous with Shasta County.

#### **RESOLUTION NO 25-06**

# RESOLUTION OF THE BOARD OF TRUSTEES OF THE \_\_\_SHASTA FIRE PROTECTION DISTRICT\_\_ 2% TAX INCREASE ON \$20 PARCEL FEE FISCAL YEAR 2025-26

**WHEREAS**, pursuant to Article 3.6 (commencing with Section 50078) of Chapter 1 of Division 1 of Title 5 of the Government Code, assessments for fire suppression purposes are imposed on parcels of real property within the Shasta Fire Protection District.

WHEREAS, in each subsequent year as part of a duly noticed public hearing, the FPD Board may choose to adopt an inflation adjustment factor by resolution to increase the maximum special tax rate by an amount of up to two percent if needed to balance the next year's budget. An inflationary adjustment may be applied annually to account for normal cost of living increases in providing fire services. This factor is the maximum that the special tax could be raised in a fiscal year.

WHEREAS, the costs of maintaining and operating fire suppression equipment as well as the operational costs of maintaining the fire station have continually risen over the 2024-2025 fiscal year.

**NOW, THEREFORE, BE IT RESOLVED** The Shasta Fire Protection District hereby increases the Annual Fire Assessment by a factor of 2% for the 2025-2026 fiscal year, from the previous assessment in the 2024-2025 fiscal year, as approved by public ballot in 2024.

a) The percentage will increase the current parcel fee of \$20.00 to \$20.40.
