Board of Directors Regular Meeting Minutes July 16, 2025

1.0 CALL TO ORDER: The meeting was called to order by Board Member Swayne at 6:00PM

- 2.0 PLEDGE OF ALLEGIANCE: Flag salute led by Board Member Swayne
- **3.0 APPROVAL OF AGENDA:** Board Member MacDonald motioned to approve the agenda, seconded by Board Member Weale. Vote to approve was unanimous.
- **4.0 APPROVAL OF PREVIOUS MEETINGS MINUTES:** Board Member Weale motioned to approve minutes, seconded by Board Member MacDonald. Vote to approve was unanimous
- 5.0 **PULBIC COMMENT:** Chris Norden with the California Special Districts Association informed the board about what he can offer. The CSDA is having a Board Member conference and invited our Board Members to attend. The conference will be held October 6th 8th. Chief Steineke asked about the cost of the conference. \$300 \$350/person. Also csda.net is a wealth of information and resources available to us. 6 month free trial with full range of benefits.

Board Member MacDonald motioned to approve Resolution 25-06, seconded by Board Member Weale. Vote to approve was unanimous

9.0 CHIEF STEINEKE UPDATE

- 9.1: Safety purchase 7 complete turnout gear have been ordered, scheduled to ship on 7/18/25
- 9.2: SCBA purchase 4 new SCBA's have been ordered \$34,070.06 end of August
- 9.3: Fire Brew Crew need to get the word out, new sign
- 9.4: Chief Steineke read to the board Pinnacle Health's proposal
